

# **GENERAL TERMS AND CONDITIONS**

## **VOLEIBOOM – SPORTS ACTIVITIES AND CAMPS**

**(updated March 2026)**

## **1. ACCEPTANCE OF THE TERMS**

Making a reservation implies the express, full, and unreserved acceptance of these Terms and Conditions by both the person making the reservation and the player.

Voleiboom reserves the right to accept or reject registration applications or to deny access to its activities for organizational, disciplinary, or security reasons.

## **2. SCOPE OF APPLICATION**

These conditions will apply to all activities organized by Voleiboom, including **VOLEIBOOM International Beach Volleyball Camp by JAVIER BOSMA Barcelona, Castelldefels**.

## **3. SERVICE PROVISION AND RESERVATION**

### **3.1 Registration Procedure**

The player must complete the form correctly, provide accurate information, and pay the corresponding fee within the established deadline.

If the activity is fully booked, Voleiboom may place the application on a waiting list.

### **3.2 Confirmation**

The booking will be considered confirmed only after receipt of full payment and sending of a confirmation email by Voleiboom.

### **3.3 Exclusions**

Registration does not include accommodation, transportation, meals, medical or travel insurance, medical expenses, or additional personal expenses, unless expressly stated on the official website.

Cash payments are not accepted.

## **4. HEALTH AND SAFETY**

Participants must inform us of any pre-existing medical conditions. Participation is voluntary and at your own risk.

If you experience symptoms such as dizziness or unusual pain, you must stop the activity immediately and notify staff.

## **5. EQUIPMENT AND CLOTHING**

It is the participant's responsibility to bring appropriate and safe equipment.

## **6. LIABILITY AND EXONERATION**

The player and accompanying persons agree to indemnify Voleiboom against any claims arising from injuries, damages, or theft.

In the event of inappropriate conduct, the participant may be expelled without refund.

## **7. CANCELLATION POLICY (Campus July 6–10)**

Cancellations must be notified in writing to [administracion@voleiboom.com](mailto:administracion@voleiboom.com).

Refunds:

- Until May 31: refund less €105.
- June 1–20: 50% refund.
- From June 21: non-refundable.

## **8. FORCE MAJEURE**

Voleiboom will not be responsible for cancellations resulting from causes beyond its reasonable control such as natural disasters, pandemics, or government decisions.

## **9. CANCELLATION BY THE ORGANIZATION**

In the event of cancellation attributable to the organization, the amount paid will be refunded, without covering additional expenses such as flights or accommodation.

## **10. CLIMATE POLICY**

Specific measures are in place for extreme heat, thunderstorms, heavy rain, or winds exceeding 80 km/h. The purpose of this policy is to ensure the safety and well-being of all participants, officials, and spectators during beach volleyball events by establishing clear guidelines for adverse weather conditions.

This policy applies to all activities organized by Voleiboom.

### **10.1 Temperature**

- Extreme heat: If the temperature exceeds 40°C, play will be suspended until conditions are safe. Access to drinking water will be ensured, and shaded areas will be provided where possible. Mandatory breaks will be taken every 15 minutes while this temperature persists.
- Cold: Play may continue in temperatures as low as 0°C, provided players are appropriately dressed and the playing surface is safe.

### **10.2 Thunderstorms**

- The game will be suspended immediately if lightning is seen or thunder is heard.
- The 30-minute rule will apply: the game may only resume 30 minutes after the last lightning flash or thunderclap.
- Participants and spectators must seek shelter in an enclosed building or vehicle during this time.

### **10.3 Rain**

- Light rain: Play will continue.
- Heavy rain: Play will continue unless water accumulates on the court, in which case it will be temporarily suspended.

### **10.4 Wind**

- Sustained winds exceeding 80 km/h (50 mph) will result in the suspension or cancellation of the activity.

## **11. PARTICIPATION OF MINORS**

Voleiboom's responsibility is limited to the official activity schedule and the designated facilities. Delivery and collection must be carried out by authorized personnel.

## **12. USE OF IMAGE**

Voleiboom may use images captured during the activity for promotional purposes, unless the participant expressly objects.

## **13. CLAIMS**

Claims must be submitted in writing within a maximum of 28 days to [eventos@voleiboom.com](mailto:eventos@voleiboom.com).

#### **14. LEGISLATION AND JURISDICTION**

This contract shall be governed by the applicable legislation in the country where the activity takes place.
